### 1. Welcome, roll call, apologies

MNU welcomed members.

### 2. Minutes of last meeting

The JIC approved the minutes of the previous meeting, held on February 6, 2019.

### 3. Agenda approval, requests for other/new business

Agenda approved with no additional items; however, there was mention from B. Blobel on the need to align the JIC with IEEE – MNU to follow up with Berndt offline on topic.

### 4. Review of action items from previous meetings

### 4. Re-evaluation of JIC Role, Activity

- a) Priority activities
- WKU stated HL7 still has concerns around JIC and their continued participation. Board agreed not
  to withdraw, but JIC needs to do self-assessment on whether they are upholding their obligations,
  responsibilities and tasks as outlined in their charter, etc.
- JMI also felt it was necessary to provide WKU with materials to take back to HL7.
- WKU observed that, in looking at website, he asked does JIC fulfill the mandate as articulated on the website. There was agreement from many in the room on need to revisit and ensure our communications represent JIC properly. It was also highlighted that there is no joint work program to review.



- CHA recommended that we should not accept new members until we solve the issues identified to date. Working resolution of executive: CHA and WKU motioned, RST opposed. Group agreed to hold off engaging new members.
- JMI highlighted that JIC calendar on the website needs to be updated

### b) Communications imperative

Update from MNU (as Chair) – asking for SDOs to distribute letter.

- SKA requested that names of orgs be placed in alphabetical order. Also got impression that JIC
  makes standards but it's the standards orgs that do. JIC does not produce standards. Wording to
  be changed/MNU agreed.
- RDH words should reflect charter (and council of equals is not in there).
- SKA website is out of date

### c) Review of membership list

- CDISC just need RFA on list
- CEN no changes
- DICOM no comment
- GSI CHA, Henri and Ulrike to remain. Ulrike to chair moving forward (CHA)
- HL7 EHA and WKU. CCH to become an observer as she belongs to separate org, WKU to decide.
- IHE MNU and LFO to remain. AOR to be removed (MNU to follow up)
- TC215 MGL, EKE, DNE, and RDH. EKE suggested she could become an observer so that TC215 have 3 attendees
- SNOMED DSW and JMI to remain
- Thanks to SJI as secretariat

BKI suggested G8GH to join as liaison and then he will participate as part of that.

CHA suggested "guests" vs "observers".

### 6. Presentation: International Patient Summaries (Update: Steve Kay)

- 5 products from collaboration (IPS/PSSS/SNOMED licenses, etc.).
- Very few stakeholders will read our standards. We need to influence decision makers/Should do more public presentations / information for public.
- Best type of communication to a broad range of stakeholders on Patient Summary? How to get messages across to range of stakeholders?

• (DNE) How do we reconcile IPS/PSSS?. (SKA) IPS is normative standard and PSSS is a guidance document. CEN produced 2 standards (data structure, and implementation guide on how to use IPS in Europe). JIC PSSS can cite these documents as part of their list.

## 7. SNOMED License Agreement (Update: Jane Millar)

- Global Patient set will be produced amalgamated set (4 free sets and 5 clinical reference sets).
   25,000 codes in their descriptions. Free for use globally. Publicly available through SNOMED website in September 2019.
- DWE (SNOMED) has offered JIC member orgs a free license.

### 8. xSDO Genomics Program Update

- Strong participation for cross SDO meetings; 3 workstreams (data and nomenclature and form 3).
- By Fall 2019, hoping to expand participation of more SDOs.
- No action required by JIC at this time. Possibility for update in the Fall.
