

### JIC Executive Meeting 5 June 2019, 19:00-20:00 (UTC)<sup>1</sup>

## **Minutes of Meeting**

Location: Teleconference

#### 5. Welcome, roll call, apologies

MNU welcomed members, and introduced new members Walter Suarez (HL7), Amit Trivedi (PCH Alliance) and Michio Kimura (IHE).

#### 6. Minutes of last meeting

The JIC approved the minutes of the previous meeting, held on April 13, 2019 in Gothenburg.

#### 7. Agenda approval, requests for other/new business

Agenda approved, as amended to include a new business item brought forward by KOD regarding a DICOM initiative to update coding for Sex and Gender.

#### 4. Review of action items from previous meetings

Action Item list: [Action Item List] was reviewed as follows:

- ISO article will have to wait until DNE is back
- Signature events are on hold until more pressing JIC priorities are adressed
- DICOM xSDO work item proposal will be addressed when JME returns
- Standards Alignment amongst SDO's will be addressed at a later meeting when EHA and WKU are on the call

#### 5. JIC Website Update and Alignment

RST presented a <u>draft document</u> designed to replace the <u>existing wording</u> on the website. At first reading, JIC members found the language well-aligned with the JIC Charter, and representative of the current direction the JIC wishes to pursue. It was noted that the document defines intent, but not processes, which need further effort.

MNU asked members to review the document, and forward any suggested comments or updates to RST and the Chair, along with a vote to approve. It is intended to update the website in about a week's time.

#### 6. Education and Opportunity Roundtable

- MNU introduced the concept of "education and opportunity" as a means for SDO's to share information about their current plans and priorities, as well as introduce topics/initiatives that other SDO's may wish to collaborate on. This concept was curated in response to recent discussions intended to return the JIC to its core mission.
- Governance of xSDO initiatives was raised, with a recognition that previous methods (eg. joint balloting) may no longer be a practical solution. It was resolved that this topic requires further discussion and resolution.
- <u>DICOM: xSDO Collaborative Work Item Proposal/Process</u>: this item was proposed several meetings ago by JME, who was not able to attend this meeting. KOD reported that this can be brought forward at the next JIC Executive meeting for presentation/discussion
- <u>CDISC</u>: RFA noted that it is difficult to identify what may be interesting to others, given that we don't have an overview of what is going on in each SDO. MNU invited RFA to present an overview of CDISC activities and potential collaboration topics at the next JIC Executive meeting.
- <u>IHE: Profile Proposal for the International Patient Summary</u>: MNU gave a short <u>presentation</u> on an IHE-led xSDO initiative to build a profile based on existing specifications and artifacts in order to strengthen adoption of IPS by the global vendor community. SDO's currently onboard include IHE, SNOMED, HL7, CEN and ISO. Other JIC member SDO's were invited to join and/or support this initiative.

#### 7. Next f2f JIC Meeting, Daegu South Korea (dinner Sat 2Nov19)

• CHA has requested that JIC plans for Daegu include a dinner on Saturday night, prior to Sunday's meeting, as the incoming JIC chair must fly out the next day and would like to meet as many JIC members as possible.

#### 8. Proposal for a JIC presentation by the Global Digital Health Partnership

- MNU suggest that a presentation by the GDHP leadership might be of interest to the JIC members, and also to attendees at the ISO/TC215 meeting. This idea was supported by those in attendance.
- MNU agreed to reach out to the GDHP to see if they might be willing to present at the Daegu f2f meeting.

#### 9. New Business:

- KOD has reported that DICOM has launched an initiative to update coding of sex and gender. Collaboration has been initiated, including the HL7 Gender Harmony project, and it was acknowledged that all SDO's will have to deal with this issue. Any interested SDO's are invited to participate in DICOM's CP1927 initiative on this topic.
- RST volunteered to update the Global Health Informatics Standards Calendar that is maintained on the JIC website, and will circulate a notice to JIC members to provide input.

# **O**Joint Initiative Council

DNE and MKI advised the Chair that the notices of the JIC Executive Committee meetings were
incorrect, in that the meeting time was intended to be standardized around 20:00-21:00 hours UTC,
but the calendar invites were not properly aligned throughout the year. MNU apologized for this
error, resulting in part because the JIC is currently operating without a secretariat. MNU will correct
this going forward, and re-send calendar invites with the correct times noted.
