The white paper working group reviewed comments and sponses and approved on what had to be acknowledged but not considered (and the reasons why) as well as the mments which found place in the white paper. That included comments on the graphics.

The process to approve the white paper is described -namely an e-voting with a doodle poll. That poll is opened during the Executive council meeting.

PNE thanks the SDO colleagues who contributed to the marketing planning. A special thank to HL7 webmaster who has been very reactive in refreshing our website.

With the help and involvement of the marketing team, assets have been developed, which had been sent to the Executive council members. A discussion took place about the "JIC relaunch" -which is in fact what is intended by the white paper and the communication triggered by it.

Now the planning is to continue communicating, with the support and involvement of JIC's constituents. White paper online this Friday (26 June), go live on July 7th.

Thank to DJO the updated website is shown to the Executive council and some propositions are expressed to even improve its attractivity.

A rolling plan for communication is presented and approved by the council.

Up to now, we haven't found a date to meet virtually with the ONC representatives. MNU notes that this meeting is not focusing on interoperability issues in the US, but ONC is representing GDHP's interoperability initiatives.

8. xSDO maintenance coordination MNU

Once the white paper done, JIC might consider providing support to SDOs having collaboration on a joint project -IPS being an example. These standards need maintenance and there is a recognized issue that the evolution of the standards should be synchronized or coordinated. That further should benefit of a governance, or a structure.

To "test the water" MNU is asking if JIC would be the right place for cross SDO maintenance, coordination, synchronization, harmonization -or at least provide the structure for this cross SDO communication so the respective standards evolve in parallel.

For RST the JIC does not have the structure and strength (in manpower, resources) to provide this support to the SDOs, specially having the mid- to long-term in view.

The discussion is tabled, and should be restarted in a few weeks, after further investigation at SDO side.

9. Any other business

UKR wishes that JIC Executive council keeps the momentum after the white paper, and invites to have another meeting in July, so the Executive council can have an in-depth discussion about expanding JIC's collaboration with other organisations.
