	To keep the momentum and continue growing awareness on JIC, PNE recommends the organisation of another openForum, which may take place before Summer 2021. The idea of showcasing SDO collaborations in the current

COVID immunisation card is commented by CCH who is organising with RHA and others a track at the May 2021 HL7 FHIR Connectathon (FCAT). The idea to leverage this project is welcomed and will be brought on the next Executive council meeting (slides to describe this are attached to the main Executive council presentation). JIC will then decide how we will express our support to the project, and how we will leverage it to showcase standard collaboration in action.

This openForum may take place before the IHE CAT (14-18 June 2021).

<u>Action</u>: JIC Executives to prepare decision on (1) form of support, and (2) if this subject should be selected for a new openForum

<u>Letter to WHO</u>. To our disappointment, no response has been received to now, even after CHA and RST expressed reminders. WSU means the Global Consortium for eHealth Interoperability could be a vehicle to get an answer. **Action:** WSU to raise WHO's attention to our letter through Global Consortium

<u>Discussion with the Austrian JIC – update</u>. CHA reports that the proposed meeting raises interest, although the meeting date remains problematic. Executive council members are invited to send their agenda item proposals to CHA with no delay. One of the possibilities would be to ask the Austrian about their roadmap for implementations and see where JIC may help achieving these goals.

Action: JIC Executives to share their propositions for agenda items with CHA asap

5. Planning next JIC ChairUKR

DICOM is preparing the chair rotation. AKL is investing within his company if the management supports that engagement. A response should be provided shortly. Secretariat would be run by DICOM's secretariat.

Action: DICOM to inform JIC Exec council at the April meeting

6. Update on pending businesses: ONC/GDHP and WHO.....RHA

RHA reports about the interoperability work stream, in which IPS is an important part (Netherlands and Austria are represented in this group, for example). RHA is pushing for US to be engaged in IPS implementation. There is still a strong enthusiasm, for example, from HL7. And the JIC collaboration is well promoted in this context.

HL7, IHE, CEN, WHO, SNOMED, ISO meet every 2nd week in a xSDO call to work on coordination and act as a group. HL7 has weekly meetings to address some technical issues, so a STU can be published soon.

7. SKMT commitments for fundingall

Executive council is reminded about the February 2021 presentation made by HGR. The current phase requests an external funding of 10 K US\$, which JIC constituents may share between them.

Some of the SDO can already commit; SNOMED International would contribute at the condition that its data can be uploaded; LOINC would have a similar approach.

The other SDO express the wish that an official demand should be formulated to each of JIC constituents, with a summary from the JIC and the documents already provided by HGR and distributed for the February meeting.

Action : HGR to send an official letter and instructions for payment.

8. Collaboration between JIC and other standard related organisations (friends of the JIC) content, invited organisations (contact names), calendar.....all
