(MITRE) would be the candidate of choice (international aspects). Rather multiplying speakers for short slots (15 minutes, max), organize small groups to represent, share, and develop the slide deck in common.

- 6. Update on pending businesses: ONC/GDHP and WHO......all RST notes that a joint session will be held at the June 2021 eHealthSummit in Portugal, where Aisha Hasan (ONC/GDHP), RST and CCH will present on the IPS.
- 7. SKMT update......all The draft letter sent to JIC Executive Council earlier this week includes a description of the 2 stages of SKMT's improvement. The points are commented: first stage includes a progress to meet SNOMED, LOINC and GS1's requirements for uploads. Its budget of 10K US\$ does not include the upload functionality. More precise budget will be available in a few days. The second stage is very detailed and will be subject of a budget by end of June/beginning of July.

Regarding the funding commitments to day, it is obvious that we will exceed the 10K US\$, which will enable the upload functionality, and be a start for stage 2.

It is expected that all SDO contribute -the amounts are modest. Currently commitments are noted for 9.5 K US\$. HGR will send a formal letter to the JIC constituents with a formal invoicing process; that is still in preparation and will follow shortly.

It is further noted that SKMT is very modestly promoted. Content of a webpage will be prepared with SKMT governance board and GS1's marketing team. More communication (including within the SDO communities) to follow when the updates will be made. In a next stage, definition harmonization will be addressed according SKMT's strategy.

Refresh the discussion JIC had last year. The IPS group is supported by HL7 and SNOMED and works efficiently to harmonize synchronization of efforts along bi-weekly calls. At some point of time, when physical meeting will be possible again, the IPS group will have to benefit of a "harbor" -which has been HL7 until now and which is likely to continue in the future.

The IPS group is focusing on a specific project/domain, and we shall not exclude that other groups of this kind will be established in the future. It is wished that JIC keeps this situation in mind to help or support such groups when their need arises.

JIC colleagues are reminded to keep the JIC calendar up-to-date for their main meetings. That facilitates the search for dates and avoids overlaps of meetings. Contact for this are RST and CHA. It is noted that the next HL7 f2f Working Group Meeting is scheduled for January 2022.
